The table below outlines the average adjustment per service as approved by the ACC Board in February 2025

Commentary:

- The percentage adjustments below, are the average increase across each contracted service. These are not necessarily reflected at a service item level. This is because the distribution of costs that impact the price of an individual service item can vary, depending on the nature of the service being purchased.
- As a result, you may notice that the adjustment outlined in your variation letter for each service item code may be different to the average adjustment percentage outlined below.
- Services with an Allied Health labour component include the final consideration adjustment for the 2023 – 2025 Te Whatu Ora and Public Services Association Allied, Public Health, Scientific and Technical Collective Agreement ('The Te Whatu Ora and PSA Agreement')
- There were no other MECA (Multi-Employer Collective Agreement) settlements considered post July 2024.
